RESOLUTIONS OF RESPECT.

Tribute From the Mason Bar to the Late Hon. John G. Hickman.

A meeting of the Mason Bar was held Saturday, at which this action was taken—

MAYSVILLE, Ky., March 30th, 1901. To the Members of the Mason County Bar: Your Committee, to whom was referred the matter of preparing appropriate resolutions in view of the death of John G. Hickman, Esq., one of your number, would report and recommend the adoption by you of the following, to-wit:

First—That a simple outline of his life should be made for permanent record, and in pursuance of these facts have been ascertained and are here stated:

Mr. Hickman was born in Washington, in this county, September 24th, 1815. His education was received in his schools and at Center College of Danville, where he graduated in 1835. He studied law under the preceptorship of William Rochester Beatty, his kinsman and a leading member of this Bar, to which Mr. Hickman was admitted by the Mason Circuit Court on the 14th day of May, 1839. From that date until the year 1868, when he retired, a period of about forty-six years, he was engaged in the active practice of his profession at this place. His only venture in political life was as a member of the State Legislature for one term, that of 1853-5. He married in 1842 Miss Phoebe Forman, daughter of George L. Forman, Esq., an honored member of one of the old and leading families of this county, she dying long before he did. He departed this life on the 10th day of March, 1901.

Second—That his course as a lawyer was an honor to the profession and in every respect commendable. It was marked by fidelity to his clients, unswerving integrity, wise and successful handling of matters entrusted to his charge, freedom from tricks or any thing that savored of insincerity or dishonesty, and uniform and noticeable courtesy to the Bench and his fellow-members of the Bar.

Third—That as a man he was not without the sterner elements of character. He had convictions as to right and as to duty and to them he was absolutely true. He spurned the wrong and loved the right. He possessed moral courage to a striking degree. But he was chiefly distinguished for the softer aspects of life. He was unpretentious, gentle, chaste and pure. If we were to emphasize any trait it would be the signal purity of his life. If any one among us was entitled to wear the "white flower of a blameless life," he, of all others, should have had that distinction. His cleanliness of spirit found expression in and was symbolized by neatness and cleanliness of person. And in reflecting upon his life and the way he walked in this community, one cannot help but think of Whittier's "Quaker of the Olden Time," of whom he said:

"The Quaker of the olden time How calm and firm and true! He walked the dark earth through, The show of power, the love of gain, The thousand lures of sin Around him, had no power to stain The purity within."

Fourth—That a copy of this report be handed to Mr. Samuel T. Hickman, his son and only surviving descendant, and that the original report be presented to the Mason Circuit Court on the first day of its next June term, with the request that it be spread upon the order book thereof.
